Dr. Kenneth J. Barnes is the Mockler-Phillips Professor of Workplace Theology and Business Ethics at Gordon-Conwell Theological Seminary and Director of the Mockler Center for Faith and Ethics in the Workplace. Prior to his academic career, Dr. Barnes spent many years as a senior international executive for several multi-billion dollar companies doing business on six continents. He has also served as a bi-vocational pastor in both the United States and the United Kingdom where he holds dual-citizenship. Professor Barnes' main areas of research and teaching are: the intersections of theology and economics and faith at work. He has published numerous papers in the U.S., U.K. and Australia. His recent book projects include: *Redeeming Capitalism* (Eerdmans) 2018; and "Religion and Business Ethics: Religious Perspectives on Business", in *The Routledge Companion to Business Ethics* (Routledge) 2018.



Canon Edmund Newell has been Principal and Chief Executive of Cumberland Lodge since 2013. An economic historian and priest in the Church of England, he was previously a Research Fellow at Nuffield College in Oxford, Chancellor of St Paul's Cathedral in London, where he was the founding Director of the St Paul's Institute, and Sub-Dean of Christ Church, Oxford. Ed is a regular contributor to *Pause for Thought* on BBC Radio 2. His publications include the co-authored books, *Ethics & Investment Banking* (with John Reynolds) and *What Can One Person Do?* (with Sabina Alkire), a theological reflection on the

Millennium Development Goals. His latest book, *The Sacramental Sea: A Spiritual Voyage through Christian History*, was published in 2019. Ed is also a Fellow of the Royal Historical Society and the Royal Society of Arts



Prof. Naoto Yoshikawa, Ph. D. is a Vice Chancellor of Tokai University where he has been teaching International Development Theory. He has worked for the United Nations Development Program (UNDP) in Zambia, and the Food and Agriculture Organization of the United Nations in Rome, Italy, Trindade and Tobago, Guyana, Surinam, and Bangladesh.
