Over 100 civil society activists have signed an appeal to the President, Government and political forces of Ukraine demanding to convene an Assembly of National Reconciliation

Kyiv, Dec. 10, 2013 — Over 100 people, including many renowned leaders of NGOs, lawyers and political experts, have signed an Appeal to the President, Government and Political Forces of Ukraine drafted last night by a spearhead group of representatives of Ukraine's civil society. The Appeal suggests an **Assembly of National Reconciliation** to be convened as an exit from the deadlock the nation has found itself after the unexpected suspension by the Ukrainian government of the EU-Ukraine Association Agreement signing and the brutal police crackdowns on participants in the mass peaceful protests that broke out following the move.

The Assembly, composed of politicians, local and regional government officials, civil society leaders, reputable scholars and other public figures, as well as representatives from international community, is expected to agree upon and sign a Declaration of National Consensus.

Part of the Declaration must be an Action Plan for the first half of 2014, beginning with the development and signing of a constitutional agreement and the signing, not later than April 2014, of the Association Agreement with the EU.

The Appeal names three preconditions for the Assembly to take place: (i) release the unlawfully detained protesters and activists; (ii) form a provisional technical government; and (iii) bring to justice those law-enforcement officers whose action and/or inaction led to the use of excessive force against peaceful protesters.

According to members of the initiative group, no round table or any other sort of negotiations between the government and the parliamentary opposition will be legitimate and effective without participation of civil society as a third party. They say, civil society activists, not politicians, took people to EuroMaydan, and members of the public, not parties, largely became victims of political oppression.

Says Hennadiy Druzenko, Vice President of the European Integration Institute and a member the group: "The civil society, which is interested in replacing the operating system in the computer called 'Ukraine' and not just rewriting a few files, is the real driver of systemic changes in the Ukrainian society and the only force that have a vital interest in such changes."

He also said that the civil society has matured enough to be a full-fledged participant in any negotiations on political crisis settlement in Ukraine.

Appeal of Civil Society Representatives to President, Government and Political forces of Ukraine

We, the Representatives of Civil Society of Ukraine,

recognising our responsibility before our descendants,

being concerned about the sudden halt of European integration of Ukraine,

condemning the use of excessive force by the special forces of the Ministry of Internal Affairs of Ukraine on the 30th of November, 2013 at the Independence Square and the 1st of December, 2013 at Bankova St.,

having no doubt that further confrontation and escalation of the conflict threatens independence, sovereignty and territorial integrity of Ukraine and may lead to social and economic collapse,

believing that it would be impossible to find the way out from the impasse, which our country faces today, only by efforts of politicians and without active participation of the Civil Society,

considering that this is the third constitutional crisis over the past 10 years,

APPEAL:

I. For the resolution of the political crisis, to initiate the Assembly of National Reconciliation aimed to approve and to sign the Declaration of National Reconciliation.

Participants of the Assembly should include parliamentary leaders of major political parties, mayors of large cities, heads of regional councils, representatives of the Civil Society, reputable scholars and public figures, and as observers, representatives of the international community, namely the EU, the OSCE, the Council of Europe, the Russian Federation and the United States of America.

The preconditions for the Assembly should be the release of the unlawfully detained activists, formation of a provisional technical Government of national reconciliation and bringing to justice officers of law-enforcement bodies, whose action and/or inaction led to the use of excessive force against participants in peaceful protests.

The Declaration of National Reconciliation should include jointly agreed Action plan for a transitional period - the first half of 2014, including:

1) elaboration and signing of the Constitutional agreement, which provides a mechanism and division of state power to the adoption of a new Constitution of Ukraine;

2) signing of the Association Agreement with the European Union by the end of April 2014;

3) development of basic principles of the new Constitution of Ukraine on the basis of a broad consensus of political forces and the Civil Society;

4) adoption of the Electoral Code;

5) assignment of a reputable independent lawyer to the position of General Prosecutor of Ukraine, who should be nominated by legal community;

6) re-election of the Chairpersons of the Supreme Court and High Specialized Courts of Ukraine;

7) election of the President, the Verkhovna Rada of Ukraine and local authorities according to the terms and conditions set out during the work of the Assembly.

II. To appeal to the leaders of major parliamentary political parties, mayors of large cities, heads of regional councils, representatives of the Civil Society, respected scholars and public figures:

- to demonstrate responsibility and political farsightedness;

- to demonstrate the ability to forget old accusations and step over the political egoism;

- to abandon the rhetoric of recrimination and the injection of passion;

- to witness the willingness to compromise and understanding;

and together with the international community to participate in the Assembly of National Reconciliation.

The present resolution is approved by the initiators of the Assembly of National Reconciliation in Kyiv on the 9th of December, 2013. It shall be open for signature by all who supports it.
